A SNAPSHOT OF OUR YOUTH

Daybreak serves youth ages 10–24

10 out of 10 meet the criteria for mental illness

9 out of 10 come from poverty

8 out of 10 have been neglected or abused

6 out of 10 have a history of drug use

5 out of 10 (age 18 and above) lack a high school diploma or GED

561 youth received help at Daybreak (26% increase).

161 youth engaged in Daybreak's street outreach services.

114 moved off the streets into a safe place.

315 youth were kept safe in our emergency shelter and provided with food, counseling, and more.

266 reunited with family or moved into another suitable home.

96 youth resided in our transitional apartments and participated in programs that help prepare them to be independent, self-supporting adults.

39 exited the program to other stable housing upon leaving Daybreak.

279 youth received employment support and training to help them find a job and succeed in the workplace.

116 youth got jobs.
